The Town Council recently adopted a Senior Tax Abatement Program giving some senior citizens over 65 another option to reduce their tax payments. The option is available based on income qualifications. Applications will be processed through the Assessor's Office in the Town Hall.

The Town of Coventry will be facing some significant financial challenges as we work on the next budget. The State faces a substantial fiscal crisis and State aid and/or grants to Coventry could be reduced. Locally we have rising costs and contracts creating an increasing burden on our budget. The Town Council has already taken steps to become more efficient, reduce costs and control spending. A new local issue of crumbling foundations will soon lower our overall grand list value and could become an expanding burden for Coventry as a community.

Comings & Goings and Staff Accomplishments

Farewell to Senior Center Transportation Coordinator **Leigh Wajda**, who has arranged rides for our senior citizens for many years. See the Senior Center page for plans for that program. We welcome **Emma King**, Senior Center Coordinator, who returns to Coventry where she grew up with a wealth of experience in senior programs.

Finance Director **Beth Bauer** has announced her retirement, pending in March 2017. She will be sorely missed. Under her leadership, the Town has again received a Certificate of Achievement for Excellence in Financial Reporting for the fiscal year ended June 30, 2015 from the Government Finance Officers Association. This is the highest form of recognition in governmental accounting and financial reporting and represents a significant accomplishment by a government and its management.

Congratulations Police Chief **Mark Palmer** who has been appointed to the Police Officer Standards and Training Council, where his expertise will benefit the entire state. Welcome to **Olivia Beausoleil**, who has joined the Department and will begin Police Academy training this month. We are recruiting for a second officer in the spring.

At the 2016 Annual Convention of the Connecticut Conference of Municipalities, the Town of Coventry received a Municipal Excellence award for the renaissance of Coventry Village. The award included a \$1,000 prize which will be used to further enhance the Village area. Stay tuned for details.

Last but not least, farewell to **Lisa Thomas**, who resigned from the Town Council after nine years of service. The remaining term of her seat has been filled by **Justin Trzaskos**, who you may know from his role as president of the Coventry Arts Guild. Welcome aboard!

TOWN MANAGER'S UPDATE

As winter sets in the Town starts working on what promises to be a difficult budget. Predictions of significant State aid cuts will be felt in either Town and Education service reductions or higher taxes. Your voice in helping make these decisions are more important than ever. You will need to share your feelings particularly at the State level.

After the Town Manager's budget, including the Board of Education budget, is released a public hearing is held. This is the best time to share your feelings. Save the date of March 9, 2017 at 7:00 PM in Coventry High School Lecture Hall. Comments to the Town Council are welcome through the end of March (see Council Chairwoman's letter on front page) and the Council's budget goes to Town Meeting on April 22, 2017 and Referendum (May 2, 2017).

Other significant concerns include the opioid epidemic. Arming our first-responders with Narcan alone is not a solution. We need to break the cycle and stop people from starting inappropriate drug use and move toward treatment. Working with our neighbors through Eastern Highlands Health District a forum and resource fair is scheduled for February 8th. See back page for more information.

Please help us decide what businesses we want by completing the Economic Development Survey (see page 9).

PROJECT UPDATE

The State Main Street project has basically reached a winter shut down. Some off-road drainage work may continue. We expect the road work and sidewalk completion in spring/summer. The delay of the culvert installation in front of Meet Me on Main has also delayed getting utilities to the Tracy Shoddy Mill.

The State-funded sidewalks in front of Coventry High are installed with spring touch-up and tree planting pending. Funds are available to extend from the new crosswalk to Hemlock Point Road.

The Lake/Cross Street project was delayed to allow design tweaks and to incorporate extra State money for additional pavement work. It will be bid this winter for a spring start. This project will fill in the missing link of sidewalks on Lake Street from Main to Monument Hill and improved intersection safety and school crosswalks.

The Library Building Committee continues to work on obtaining necessary State approval for Council consideration on proceeding to referendum. A State grant is installing a new fiber optic connection to the Library which will reduce current Internet/transport costs.

The lake gate replacement project is underway with hopes of getting concrete poured before winter firmly settles in. We still have control of the lake and can raise the level if construction is delayed too long.

The Town is waiting for delivery of a used Quint (ladder truck with water) and a tanker truck for our Town fire services. Both are

firsts for us and have been recommended by several consultants for over ten years. The volunteers will need to undergo a lot of training to use these apparatus. They are the start of a replacement plan for vehicles over 20 years old.

We continue to work on transferring the ambulance operation to the Town and await a decision from the State Department of Health. We are served during the weekdays by a paid staffing agency which has greatly increased our response time. Volunteers still respond to night, weekend and multi-ambulance calls. They need your help so please consider becoming a volunteer EMT or firefighter.

We are on the home stretch of acquiring the development rights for 89 acres of the Reynolds Farm on Flanders Road. A generous grant from the State matched with funds from the CT Farmland Trust, Joshua's Tract and our own open space fund made this possible. We expect ownership within the month. We also are finally getting toward the finish line for the Williams open space purchase for 62 acres between Cooper Lane and the Willimantic River. Still need the sign off from several heirs to clean up the title.

The Building Energy and Efficiency Committee is moving from the natural gas conversion project to other building code, security and energy construction projects. It is anticipated that by spring a detailed review of needs and costs will be completed for consideration.

TAX COLLECTOR'S OFFICE

The 2nd installment for real estate taxes are due January 1, 2017. The last day to pay without interest is February 1, 2017. Real Estate tax bills are **not** mailed out for this installment; please use the second payment portion of the 3-part bill that you received in July.

Supplemental Motor Vehicle bills for a vehicle purchased, registered or plates transferred after October 1, 2015 and before August 1, 2016 were mailed in mid December and are due January 1, 2017. The last day to pay without interest is February 1, 2017.

Please remember that the Webster Bank Lockbox address in Hartford, printed on your original bills, will only process mailed payments for **CURRENT TAX BILLS**: Real Estate tax due January 2016 and Supplemental Car tax due January 2016. All other payments for any delinquent bills or partial payments should be mailed directly to the Coventry Tax office 1712 Main St. in Coventry 06238 for processing.

If payment is received after February 1, 2017, the Real Estate and Supplemental Motor Vehicle tax bills become delinquent and are immediately subject to 3% interest. From then on, interest is added at the rate of 1.5% per month from the due date.

On-line credit card payments for tax, sewer and trash bills are processed by Official Payments Corporation. When

paying by credit card, you will need your bill number, tax and updated interest amount and Coventry's jurisdiction code (1721). From the Collector's page on the Town's website, there is a Quick Link to Find Your Bill or you may call the tax office for these details including the toll free number and web address for Official Payments Corp. A link to Official Payments Corp. web site can be found on the Town's web page: www.Coventryct.org.

Taxpayers have an additional on-line payment option for those wishing to pay by check/debit (EFT). You will need to know the Grand List date and list number of each bill you pay. If you cannot find your bill, check the Quick Link to Find Your Bill from the Collector's page on the website. You may need to contact this office to obtain or verify this information. From the Tax Collector's page on the Town's website, choose payments from bank account for this preference. This will connect you to Webster Bank's payment link site. You can save time, gas, postage and the inconvenience of driving in bad weather by paying online or by phone.

Taxpayers owing delinquent motor vehicles taxes must pay all motor vehicle taxes by cash or money order for an immediate DMV clearance. Payments by personal check will result in a delay of ten (10) business days for the DMV clearance. On line payments will result in a delay of three (3) business days from the day your payment is processed by the Tax Office for a DMV clearance.

ASSESSOR'S OFFICE

The Elderly or Totally Disabled Homeowner Program begins February 1, 2017, and applications are being accepted until May 15, 2017. Our office will be sending reminder letters by the end of January 2017 to those people who have to re-file this year. Remember that this program is income driven from the state and income guidelines are set by the state for both single and married individuals. Please call if your income is less than \$42,900 if married, or less than \$35,200 if single, both must include Social Security benefits and your adjusted gross income from your 2016 Federal Income tax return. There is a new option this year for a local tax credit of 50% of the State program.

The Additional Veterans Program also starts February 1, 2017 and applications are accepted until October 1, 2017. A DD214 must have been filed with the Town Clerk prior to **October 1st, 2016** to be eligible for this additional exemption. If you have already filed and did not receive a letter from our office, you do not need to re-file. You will receive your exemption automatically. For additional veteran's benefits, please call if your income is less than \$42,900 if married, or less than \$35,200 if single, both must include Social Security benefits and your adjusted gross income from your 2016 Federal Income Tax return.

You will be asked to provide proof of all the income documentation regarding both of the above mentioned applications. Additional Veteran's and Homeowner applications are taken biannually.

Crumbling Foundations has been an ongoing issue for 19 Towns in the eastern part of the State. Connecticut General Statutes have allowed the Assessor's Office to revalue the property starting with the 2016 Grand List. Applications are on our website and in the office. These must be filed along with a certified Engineers report in order to receive an adjusted assessment. The annual deadline for the Grand List is December 1 each year. Seventeen households used it this year.

The Board of Assessment Appeals will be meeting in March of 2017. Appeal **applications must be filed no later than February 20, 2017**. The board is required to here all appeals concerning Motor Vehicle, Personal Property or Real Estate. Applications are available in the Assessor's Office or online at www.coventryct.org.

2017 licenses are available at the Town Clerk's Office or from the DEEP website www.ct.gov/deep/hunting. Remember, all licenses expire annually on **December 31st** except Lifetime and Handicapped Licenses issued before October 1, 2009.

CONNECTICUT MIGRATORY BIRD CONSERVATION STAMP ART CONTEST

Artists are invited to enter the contest by submitting an original piece of artwork that depicts a waterfowl species (duck, goose, or brant) that occurs in Connecticut. The winning entry will be featured on the 2018 Connecticut Migratory Bird Conservation Stamp.

Legislation that became effective on July 1, 2016 established the **Resident Game Bird Conservation Stamp** (which replaces the Pheasant Stamp and turkey permits) and made changes to the **Connecticut Migratory Bird Conservation Stamp**. The Resident Game Bird Conservation Stamp is required to hunt any resident game birds in Connecticut, including pheasants, ruffed grouse, partridge, quail, AND wild turkey. The Connecticut Migratory Bird Conservation Stamp is required for anyone hunting waterfowl, rails, snipe, woodcock, and crows.

These new changes are not in the printed version of the 2016 Hunting & Trapping Guide.

CRUMBLING CONCRETE FOUNDATIONS:

A very significant issue is emerging in our region. Houses built with concrete from certain suppliers had a mineral called pyrrhote which over time appears to cause a chemical reaction which cracks the concrete and diminishes the structural strength. Coventry had almost 2,000 houses built during this period and many additions. Using a very conservative assumption of 30% of these houses having impact we are looking at around 600 houses. Currently the recommendation for remedy is total foundation replacement including footings. This may change as more knowledge of the chemical reaction becomes known. Total replacement is estimated between \$150,000 to \$200,000. The Council is considering waiving building permit fees for replacement.

The Town is working diligently with our neighboring communities to develop solutions and seek aid. Currently 17 houses in our town have applied for reductions of their assessment (December 1 deadline annually). Working with the Capitol Region Council of Governments, we obtained bids for testing and engineering services and vetted contractors. Proposed legislation for a relief fund is being prepared for consideration but the State's fiscal position will be an obstacle and strong public support will be needed. We are also seeking Federal grants.

BUILDING DEPARTMENT

The Building Department would like to remind residents to prepare for weather emergencies before they happen.

- Generators and supplemental heating equipment should be serviced prior to use to ensure safe operation when needed. Generators must not back feed to the power grid. Approved transfer switches are required to protect the utility line crews.
- Residents are also encouraged to read all operating instructions on gas log sets and vent-free L.P. heaters. These units should not be used beyond the limits of their listing. Carbon Monoxide detectors should be placed outside of sleeping areas in all households that burn fossil fuels.

- Chimneys should be cleaned prior to use and as often as needed during the heating season to remove creosote accumulations from wood burning appliances.

Apply for spring projects during the winter months when there is more time to review lengthier projects that are meant to start in the spring, such as additions and new home builds. Approved permits are valid for work to begin within 6 months of issuance date.

Please call the Building Department to arrange for final inspection if you have not received a Certificate of Completion or Completion for Occupancy.

NEWS FROM THE COVENTRY FIRE DEPARTMENT

The North Coventry Volunteer Fire Department wants to wish everyone a safe and happy holiday season! During these winter months, we have some home safety tips to share.

We would like to remind all building owners that you should have your heating appliances inspected and serviced. If you are doing a new install, please discuss this with the Fire Marshal and Building Official before any work is started. Furnaces, wood stoves, and chimneys are examples of heating components that need yearly attention. Proper disposal of ashes is

important and many times over looked. Use a metal container and let them cool before further disposal. Never use a flammable container (including tipper barrels) and do not leave them near your home or other combustible materials.

If you have not already done so, change your smoke detector batteries. It is good practice to do this when you change your clocks. The National Fire Protection Association recommends changing your entire smoke detector after ten (10) years of use. Don't forget about the carbon monoxide detectors. At a minimum, it is recommended to have 1 of each device on each level of your home.

Are your house numbers visible? Can you see them in the daylight AND at night time? If the answer is no, think about the Emergency Services trying to find your house at night, in the rain or snow. FROM THE FIRE MARSHAL'S OFFICE

With recent house fires that have occurred throughout Connecticut, here is some interesting and useful information about being fire smart with electricity throughout your home.

Did you know...

- There are nearly 47,800 home electrical fires each year.
- About half of these fires involve lighting equipment or home electrical wiring.
- Home electrical fire deaths peak between midnight and 6 a.m.
- Nearly half (46%) of electrical fire deaths happen December through March.

Here are a few words of advice on the matter...

- Plug only **one** heat producing appliance (i.e. coffee maker, space heater, microwave) directly into a wall outlet at a time.
- Extension cords should only be used temporarily. Have an electrician install additional wall outlets where you need them.
- Never use an extension cord with a heat producing appliance!

The following plastic and film items can be dropped in the containers at these locations...please be sure they are clean and dry...Bread bags, napkin/paper towel/bathroom tissue/diaper wrap, produce bags, newspaper bags, grocery bags, pallet wrap or stretch wrap, dry cleaning bags, snack or beverage cases wrap, retail bags, plastic air pillows used for shipping fragile packages, food storage (zip lock) bags, any other film packages marked with the recycle emblem. 2016 ROAD WORK AND CONSTRUCTION PROJECTS

Road/Hardscape Bond: The Road/Hardscape Bond work is nearly complete. Work included improvements to 17 miles of town roadways, reconstruction of parking lots at Town Hall and CHS along with construction of the Pre-School parking lot. The Bond will be completed in 2017 with approximately 10 miles of chip seal to town roadways and construction of a new tennis court at CHS in the spring of 2017.

Village Road Improvements: Phase II of the village reconstruction is complete except for final paving on Bradbury Lane. Paving will be completed in spring of 2017.

The Connecticut Department of Transportation Main Street Project began in April 2016. The Project involves the complete reconstruction of Main Street from the First Congregational Church to the intersection of Lake Street and Stonehouse Road. Vertical and horizontal roadway alignment and significant storm water improvements along with streetscape amenities are expected to be completed by November 2017.

Coventry Lake Dam Improvements: Work has begun on the Coventry Lake Dam and will continue into winter as weather allows. Completing of the project is expected in spring 2017.

WATER POLLUTION CONTROL AUTHORITY

Projects Update:

- Main Street Reconstruction: The majority of sewer work related to the project has been completed and tested. The few remaining sewer items are outside of the roadway and will be completed in the spring.

- We have been working with our engineers and officials from Bolton and Manchester to implement an inter-municipal agreement for the western Route 44 Sewer Planning Area in order to be prepared for any future development in this area. Bolton has indicated interest in entering into an agreement but a hydraulic study of Bolton's sewer system needs to be performed before we can move forward. We continue to work with our engineers to refine the scope of the study.

We Need Your Help:

Lately we have been noticing a startling increase in the 2 leading causes of sewer blockages; cloth wipes and grease. Grease sticks to the insides of sewer pipes like glue and builds up causing the usable flow line to shrink. Eventually grease can completely block a pipe causing backups and overflows. Cloth items like wipes do not break down in the system like toilet paper and get hung up on pipe joints, bends, and imperfections inside the pipe. This catches other debris causing it to get stuck and build up, leading to blockages. Wipes also jam up our pumps wasting valuable time and resources to remove. Simply put poo and pee go down the drain. Grease, wipes, and other cloth items go in the trash.

Sump pumps and other illegal "clean water" connections continue to be a problem. The clean water takes up precious capacity in the sewer system and limits the number of new connections we can allow into the system, which would help to defray operating costs and spread them over a larger user base. We are working hard to identify sources of clean water and to remove them but we still need your help. If you know you have clean water connections into the system or are unsure we would be happy to help you investigate and/or offer alternative methods for getting the water out of and away from your house. Voluntary inspections will never result in fines or other penalties, we just want the water out of our system.

Commercial Users Must Remember the facility is not intended for commercial users although small repair/remodeling contractors doing work for Coventry residents may be allowed limited use to dispose of materials incidental to their work within the limits of the Town of Coventry. Proof of residency and **building permits, as applicable**, will be checked as part of normal facility operations to insure the facility waste stream remains residential in nature.

Materials acceptable with cost:

- Construction and demolition debris. Free of cardboard, metal and garbage.
- Land clearing debris; stumps & brush.
- Appliances with CFC's (Freon) \$10 each, no weigh-in necessary.
- Tires – automobile size – on or off rim \$5 each.

Materials acceptable no cost:

- All electronics
- Appliances without CFC's (Freon)
- Scrap metal materials (metal tanks must be cut open and crushed)
- Gas grill propane tanks for recycling

TEXTILE RECYCLING

The Town is starting its third year of a contract with Bay State Textiles for textile recycling. Acceptable items for recycling are footwear, clothing, accessories, linens and stuffed animals. For instance, a stained t-shirt or torn bath towel becomes a wiping cloth, a lone sock becomes pillow stuffing, worn out denim jeans are used to produce household insulation, a teddy bear is used for car seat stuffing and so on. Everything will be accepted from gently used to ripped or with broken zippers. It is important, however, that they be clean, dry and bagged. Recycling these materials should reduce our tonnage disposal fees. Collection boxes are located at the town's transfer station, Public Works Department on Olsen Farm Road and at the Town Hall next to the Annex. We receive revenues averaging \$70 / month for approximately 1400 lbs. of textiles.



Christmas trees may be dropped off at the Transfer Station near the intersection of Plains Roads & Rt. 31 when the facility is open or there are two unstaffed sites: Laidlaw Park on Merrow Road and the Miller Richardson Athletic Field (take Route 31 to South Street Extension then a right at the stop sign) look for the signs. Please leave only the tree; **take plastic bags/netting home to dispose with normal garbage.** The trees will be chipped up and used in landscaping next spring. All American Waste will not pick up trees curbside.

WINTER TIPS

Parking on town roads and town owned parking lots is prohibited between 2 a.m. and 6 a.m. November 1 through March 31. Public Works may also issue no parking bans that will not allow any parking on the roads and lots throughout the town. You may elect to receive emails or phone messages regarding parking ban and snow information by clicking on 'Notify Me' on the town's website, coventryct.org, or get your news by listening to local radio or watching area television stations for parking ban information.

Remove basketball hoops from road right of way so as not to hinder snow removal.

It is helpful to **mark edges of property** that are close to the right of way with reflective snow markers. Many times it is difficult to distinguish the edge of the roadway when snow has blanketed the area.

Do not discharge sump pumps into any roadway. This is the cause of many localized icing conditions!

Placing snow in the road is dangerous, and can include penalties up to a lien against your property. A Town ordinance obligates the property owner, so if your driveway contractor or neighbor deposits snow in the road from your property, you are still held responsible. It only takes a few more minutes to push it up beyond a curb line or stockpile it on some unused land away from the travel portion of the roadway.

Remember the safest way to **travel** during inclement weather is not to travel at all. If you must travel, reduce speeds, and use caution appropriate for prevailing conditions.

Each winter, **mailboxes** may be damaged during winter maintenance operations. More often than not, damage to mailboxes is caused by snow pushing against weakened posts or hardware. If you can move your mailbox with your hand, it probably needs maintenance. Take the time to make any repairs needed so your mailbox will be strong enough to survive the winter. Proper maintenance may help to prevent damage that results in delayed mail delivery, or worse, having to make alternate delivery arrangements. Place a deflector just before the mailbox to knock the snow down before it hits the mailbox.

The town's policy is to repair mailboxes **only** when the plow truck physically hits the mailbox – not when the snow that comes off of the plow strikes the mailbox.

TRASH & RECYCLING

The following general guidance is provided to assist you in properly disposing of your solid wastes and preparing your recyclables for curbside pickup by the Town's contracted hauler, All American Waste. Detailed information is available at the Public Works garage at 100 Olsen Farm Road or the website at <http://www.coventryct.org/index.aspx?NID=221>. If you have specific questions please contact the Public Works Department at (860) 742-6588 between the hours of 7 a.m. and 3 p.m., Monday through Friday.

If materials are not picked up from the curbside, residents are asked to please call All American Waste ASAP at (860) 289-7850 to give them a chance to correct the problem or provide information on why the item was left.

Holiday Trash / Recycling Pickup Schedule Changes ONLY for the following date: No service on Memorial Day, Monday, May 29, 2017. Resume service May 30, 31 and June 1, 2, and 3.

Optional Services by All American Waste (rates extended through 7/31/2020): The cost of "as-scheduled" curbside pickup of oversized waste such as mattresses, bureaus or couch, per pickup, and transportation shall be \$175 for three items, \$225 for six items and \$350 for up to ten items per instance.

DUMPSTERS - For major cleanup projects, the current COVRRRA contract with All American Waste also includes pricing for 6, 15 and 30 cubic yard dumpsters. Residents contract directly with All American Waste at (860) 289-7850. Be sure you specify you are a Coventry resident to get this special rate. Dumpsters are for up to 30 days. After 30 days a \$5/day rental fee applies. These containers are to be used by the residents for special projects complying with the COVRRRA regulations and are not to be used for disposal of normal municipal solid waste.

- 6 cubic yard dumpster - \$150 haul / \$80 ton of disposal
- 15 cubic yard dumpster - \$175 haul / \$80 ton of disposal
- 30 cubic yard dumpster - \$175 haul / \$80 ton of disposal

- soda/juice/water bottles (glass or plastic)
- food containers
- glass bottles/jars (any color)
- aluminum cans/clean foil
- metal cans (tin/steel/aluminum)

Next to the recycling cart:

- Automotive batteries; one bi-weekly.

On top of the trash cart under the lid:

- Auto or light truck tire; removed from rim, one per week.

Used motor oil and antifreeze should be brought to the Public Works Facility at 100 Olsen Farm Road. The new facility is equipped with a used motor oil furnace. Please call (860) 742-6588 for more info.

Material acceptable for monthly oversized waste pickup (non-metal material that is too large to be placed in your tipper cart, of residential nature such as furniture).

Residents are allowed to place up to **three** non-metal oversized waste items (for example: table, couch, mattress) at the curb each month for collection as part of the program. No electronics, they can be taken to the transfer station for free disposal. **All residents need to place their items at the curb by 6:30 a.m. on the 2nd Monday of the month.** This collection may/may not follow the daily waste & recycling pickup schedule.

- Furniture such as table, couch or mattress
- Brush; trimmed to 3ft. lengths, bundled & tied, 30-lbs. maximum.
- Wood lumber; length & width less than 4 ft., less than 4 in. nominal size, 30-lbs. maximum.

Quarterly Curbside Metal Pickup has been discontinued since June 2010.

- Scrap Metal and appliances must be brought to the Coventry Transfer Station at 325 Main Street at no cost. Appliances with CFC's (Freon) are \$10 each.
- Antifreeze must be brought to Coventry Department of Public Works at 100 Olsen Farm Road. Please call (860) 742-6588 Monday through Friday 7 am to 3 pm for more info.

MUNICIPAL EXCELLENCE AWARD

The Town was recently awarded the Connecticut Conference of Municipalities' (CCM) 'Municipal Excellence Award' for all of the creative and collaborative efforts that the Town has demonstrated over the past twenty years in the renaissance and enhancement of Historic Coventry Village. Improvement of the quality of town service, development of effective ways to solve common problems, application of money saving measures such as grant funding leveraging, as well as community and Town Staff involvement were all recognized with the award. The Town Manager and Chair of the Town Council received the award at an annual exhibition sponsored by CCM.

EASTERN GATEWAYS TRANSPORTATION STUDY

The towns of Bolton, Coventry, Mansfield, and Tolland and the University of Connecticut are partnering with the Capitol Region Council of Governments (CRCOG) to study the RTE 44 and 195 transportation corridors. These corridors have been identified as needing a comprehensive transportation plan that provide sustainable solutions to meet the current and future travel demand anticipated for the communities. Key considerations for the study include: enhancing safety, capacity, access management, connectivity, and multimodal options, while factoring in smart growth planning, fostering livable, economically sustainable communities, as well as complete streets. The study is being prepared with the consulting firm of Fitzgerald & Halliday, Inc. in association with WSP Parsons Brinckerhoff and Ninigret Partners. A Technical Advisory Committee consisting of municipal staff from each town, representatives from UCONN, as well as special interest groups will help guide the overall process of the plan development. A study website (<http://www.cteasterngateways.com>) has been launched that serves as a clearinghouse of information with the ability to sign up for regular newsletter updates. ECONOMIC DEVELOPMENT SURVEY

RECREATIONAL TRAILS GRANT PROPOSAL

Since 2013, the towns of Andover, Bolton and Coventry worked with the State of Connecticut Department of Transportation (CT DOT) to pursue the conveyance of the former RTE 6 Expressway properties that were acquired to allow for the construction of a new highway through the towns. The expressway project did not proceed beyond design and permitting and ultimately was not constructed. The goal was for the towns to own the property and preserve it as open space and enable a future multi-purpose, low-impact trail system. Approximately 277 acres were conveyed to the Town earlier in 2016. The Towns of Bolton and Coventry are cooperatively working on a State of CT DEEP Recreational Trails Grant application to seek funding to hire a consultant to plan and design a multi-use trail system on the former CT DOT property. The Town's hope is provide a positive ending to a long, controversial matter in Eastern Connecticut that affected many residents. HISTORIC PHOTOS PROJECT

WORRIED ABOUT WINTER HEATING COSTS?

The Connecticut Energy Assistance Program is designed to help offset the winter heating costs of Connecticut's lower income households, specifically those households whose incomes fall at or below 60 percent of the state median income. On behalf of eligible households, the winter heating assistance pays for such heating sources as oil, natural gas, electricity, propane, kerosene, coal, wood and wood pellets. Homeowners and renters may apply. Households eligible for the winter heating program may also be eligible to receive weatherization assistance. This can help conserve energy and lower heating bills.

Please note, this is not an entitlement program and applicants will be awarded grants on a first come, first serve basis. Operation Fuel is a non-profit agency.

CLERGY FUEL FUND

COVENTRY SCHOLARSHIP FOUNDATION:

The Coventry Scholarship Foundation Dollars for Scholars is celebrating the completion of its 25th year of operation. A MESSAGE FROM THE COVENTRY LAKE ADVISORY & MONITORING COMMITTEE

Coventry Lake is the centerpiece of our community and steps were taken in 2016 to maintain the Lake's health:

- The aquatic invasive plant hydrilla was treated in August. The initial reports by CT State and local limnologists are that the treatment caused no serious impact and the hydrilla was dying. Look for more updates in 2017.
- The lake gate project has started. The lake is at a very low level, the brick gate house has been removed ready for the concrete pour (December). Look for the finishing of the project in the Spring of 2017.

COVENTRY PUBLIC SCHOOLS 2016-2017 GOALS: It is the mission of the Coventry Public Schools to prepare every student for life, learning and work in the 21st century. Embracing this vision, we began the 2016-2017 year with a continued focus on technology initiatives, instructional improvement and creating a learning environment where students and staff feel safe and respected.

Goals for each school administrator are in support of the Board of Education and Superintendent of Schools' Goals for the Coventry Public Schools. Each department's goals for the school year can be found on our website at www.coventrypublicschools.org. Below are the Superintendent's Goals for the 2016-2017 school year.

1. **Identify, define, and measure the critical skills and attributes that are required for success and align systems to continuously improve student performance and achievement.**
 - Continue the process of disaggregating Smarter Balanced Assessment (SBAC) and SAT data to inform pedagogy and the development, redesign, and alignment to the Connecticut Core Standards (CCS) of formative and performance based assessments.
 - Revise the science curriculum to align to the Next Generation Science Standards to articulate and coordinate skills vertically and incorporate 21st century experiences K-12.
 - Plan, strategize and implement the recommendations from the Assessment Reduction Committee for year two.
 - Continue the refinement and development of a PreK-12 autism program and develop a five year strategic plan designed to address current and future needs by working with internal and external stakeholders focusing on the needs of students on the autism spectrum.
 - Continue the work with key stakeholders to analyze essential data to develop and refine the district improvement plan to include multiple measures of student performance that will continue to provide the foundation and through-line for all initiatives related to instruction and student achievement.
 - Strengthen partnerships with two area districts and Eastern Connecticut State University (ECSU) to continue exploring the possibility and financial and cultural impact of establishing a dual enrollment for credit program.
 - Work with district and preschool staff to organize and complete the NAEYC reaccreditation process, demonstrating continued compliance with the 10 NAEYC Early Childhood Program Standards.
 - Oversee and assess the additional Smart Start classroom and evaluate the current structure of the preschool and special education program to ensure the program maintains the needs of pre-school students, parents and the community.

- Work with key stakeholders and the district's Technology Committee to develop action plans to implement year two of the Technology Plan and ensure continued effective integration of technology into curriculum, instruction, and assessment.
- Continue to pursue outside funding sources to support district initiatives in an effort to reduce the overall funding necessary in the district budget to implement or continue district priorities and initiatives.
- Work with district and community stakeholders to ensure the successful transition of our Chinese teacher and ensure the successful development of a middle school world language program that looks to future needs.
- Begin the process of exploring, and possibly developing, a five year strategic plan to implement a 6-12 STEM track.

2. Maintain and promote a positive and respectful learning community.

- Continue working with local law enforcement personnel in developing safety programs to increase student awareness of current and future challenges they may experience inside and outside of school.
- Work with district personnel, town agencies, and safety experts to continue the development of a plan to redesign site entryways to further address best practices related to student safety.
- Evaluate ongoing student management data as it relates to the middle school's Positive Behavioral Interventions and Supports (PBIS) framework, while promoting positive school climate and increasing educational outcomes for all students through year one of the alternative education program and participation in the Juvenile Review Board (JRB) process.
- Grow district connections with area businesses to increase the exposure of the quality programs occurring at each of the sites.
- Monitor the status of the noncompliance issues noted in the Voluntary Corrective Action Plan as a result of the Office of Civil Rights inspection and report.
- Develop centralized social media outlets to enhance and expand positive parent and community communications.
- Refine and expand the Smart Start summer program to address the needs of students ages 3 to 5 to ensure the district fulfills the requirements of the Smart Start grant.
- Explore and evaluate, with key stakeholders, town personnel and outside organizations, the impact current climate and proactive response strategy protocols have on safety, student engagement and achievement, and overall student and staff well-being.
- Evaluate the teacher-inspired Innovative Grant projects which impact student learning and achievement.

3. Recruit, retain and develop high quality staff at every level.

- Evaluate the "Most Valuable Patriot" program created to recognize and honor staff who have demonstrated outstanding leadership and have gone the extra mile to prepare students with the skills they need to succeed in the 21st century.
